

Resources for Responding to SBTi's Call for Evidence on Market Certificates

The Clean Energy Buyers Association (CEBA) has compiled a list of resources for our response to the Science Based Targets Initiative's (SBTi's) <u>Call for Evidence on the Effectiveness of the Use of Environmental Attribute Certificates in Corporate Climate Targets</u>. CEBA encourages other organizations to <u>submit their own responses</u> to SBTi before the November 24 deadline. The resources we list emphasize the crucial role of energy attribute certificates (EACs) in driving clean energy investments and project development that reduce corporate greenhouse gas emissions.

CEBA's response focuses on:

- The role bundled EACs have played in driving carbon-free energy deployment and reducing greenhouse gas emissions.
- The inability to tackle supply chain and Scope 3 greenhouse gas emissions without the use of EACs.

Together, we can activate a global community of energy customers and ensure the voluntary procurement market continues to grow and help decarbonize the grid for all.
